THE SUPPORTED HOUSING PROGRAM PROVIDES INDIVIDUALIZED HOUSING-RELATED CASE MANAGEMENT SERVICES AND RENTAL ASSISTANCE TO 42 ADULTS RECOVERING FROM SERIOUS MENTAL ILLNESS, WHO WISH TO OBTAIN PERMANENT, AFFORDABLE, INDEPENDENT HOUSING. THE SINGLE ROOM OCCUPANCY PROGRAM, PROVIDES HOUSING AND SUPPORTIVE SERVICES AND SUPERVISION TO 9 ADULTS RESIDING IN OUR 9 BEDROOM SRO.
